On appeal to the court of appeals, we affirmed the judgments of conviction. On petition for review we are concerned only with the propriety of the sentence. We hold that the trial court was clearly in error in sentencing both to life imprisonment. In the original sentencing the circuit judge said, "Court's ordered: The defendant, Michael David Spradlin and Raymond Salazar... are to serve a term of life imprisonment for their conviction of kidnapping under Ark. Stat. Ann. § 41-1803 and a term of twenty-five years for their conviction of kidnapping under Ark. Stat. Ann. § 41-1801." The convictions of rape and kidnapping were based on separate incidents. Both were admitted to the deputy prosecutor by the appellants. The rape took place the day after the kidnapping. The trial court knew that the two life sentences were to be served consecutively. He sentenced them to the maximum punishment for kidnapping without consideration of the fact that this was a separate offense. He therefore acted without the benefit of our \*715 rules on consecutive sentences. Ark.Cr.P. Rule 32.1. In Bateman v. State, 274 Ark. 63, 621 S.W.2d 130 (1981), we said: [W]e hold that imposition of consecutive sentences for offenses arising out of the same conduct is error where the trial court fails to find facts warranting a finding that the offenses were committed in a separate and independent manner. Thus, the case was remanded for resentencing. On the second appeal, we said in Bateman v. State, 285 Ark. 239, 686 S.W.2d 430 (1985): Appellants were convicted of eight counts of rape. We hold that
